The Pass the Torch scholarship/loans are provided by the Retired Ministers and Spouses of the Great Plains Conference of The United Methodist Church. Since 1991 Scholarships have been given to women and men attending seminary. The retired ministers, their families, and many other persons have seen this need and have given in memory and in honor of a Christian brother or sister. Only the interest from the money is used for scholarship/loans.

I have read the eligibility guidelines for Pass the Torch Scholarship/Loans and have completed the application to the best of my ability.

I plan to return to the Great Plains Conference following my graduation from Seminary and will serve in the Pastoral Ministry under an appointment from the bishop for a period of five years. This ministry may assume many forms, i.e., pastoral ministry or appointment beyond the local church. For the LOAN to become a full SCHOLARSHIP, five years of ministry must be completed under the bishop's appointment following seminary graduation.

Eligibility Guidelines **for Pass the Torch Scholarship/Loan**

- A. The applicant must have been a full member of the United Methodist Church for at least one year.
- B. The scholarship is limited to a seminary student who:
- (a) Is from the Great Plains Conference
 - (b) Is a certified candidate for ministry by District or Conference Board or Ordained Ministry.
 - (c) Is enrolled in seminary as a full time or part time degree candidate in a seminary approved by the University Synod of the United Methodist Church.
- C. Scholarship applications for college, undergraduate study or post graduate study beyond seminary will not be considered.
- D. Preference will be made for a student attending a United Methodist seminary over a non-United Methodist Seminary and Candidates from or serving church in the Great Plains Conference. The committee reserves the right to take unusual circumstances into account if such are present when a final decision is made.
- E. The scholarship will be for one year only. To be considered for any subsequent years, another application must be submitted.
- F. The scholarship is a grant, but will become **identified by the committee as a loan if:**
- (a) The recipient does not return to the Great Plains Conference following graduation from seminary.**
 - (b) The recipient does not serve a minimum of five years in the pastoral ministry in the Great Plains Conference.**
 - (c) The recipient withdraws from seminary.**
- In the event that a situation described in (a), (b), or (c) occurs, the amount of the scholarship must be repaid on a monthly basis with interest at 3% as established by the scholarship committee. Repayment must begin no later than six months after default on the scholarship agreement. After two notices that the scholarship was now a loan and no response has been received a letter will be sent to the Bishop and District Superintendent where they are serving to be placed in that minister's file.**
- G. Financial need will be among the criteria for granting the scholarship. If the applicant is the recipient of other scholarship aid, that also becomes a factor in granting the scholarship.
- H. Payment of the scholarship will be made directly to the seminary where the student is enrolled.
- I. This fund will be under the direction and control of the Pass the Torch Committee. The Committee will make any final decision on the awarding of the scholarship to an applicant. The Committee may seek advice and counsel of the Bishop and Appointive Cabinet or any other group or agency to help with any final decisions if it so chooses.
- J. If any other pertinent factors arise as the program develops, the Pass the Torch Committee reserves the right to change or amend or adapt the program to meet such need as it may choose.
